ARTICLES OF INCORPORATION

of

Under Chapter 621 of the Professional Service Corporation and Limited Liability Company Act

The undersigned, for the purpose of forming a professional service corporation under Chapter 621 of the Florida Professional Service Corporation and Limited Liability Company Act, hereby certifies:

1. The name of the corporation shall be:
