ARTICLES OF INCORPORATION
OF
MOSTAFAVI, M.D., P.A.

The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME: The name of this corporation shall be **MOSTAFAVI, M.D., P.A.**

ARTICLE II

ADDRESS: The mailing address is 1485 Lands End Road, Manlapan, Florida 33462 and the street address of the initial principal office of the corporation shall be 2800 South Seacrest Boulevard, Suite 200, Boynton Beach, Florida 33435.

ARTICLE III

NATURE OF BUSINESS: The corporation is organized for the purpose of providing medical services and for transacting any and all business for which corporations may be formed under Chapter 621 of the Florida Statutes, as amended from time to time.

CAPITAL STOCK: This corporation shall be authorized to issue 100 shares of \$1.00 par value common stock.
