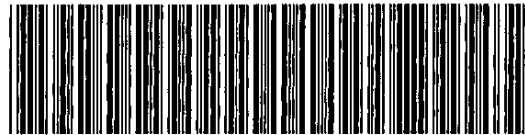

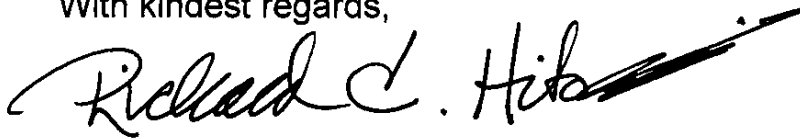

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Professional Service Corporation to be governed by the provisions set forth under the "Professional Service Corporation Act" Chapter 621, Florida Statutes.

**ARTICLE I. NAME**

The name of the Corporation shall be R.C. Hitchins & Co., P.A. The principal place of business of this Corporation shall be 325 South Olive Avenue, West Palm Beach, Florida 33401.

**ARTICLE II. SPECIFIC BUSINESS PURPOSE**

The specific business purpose of the professional service corporation shall be to perform all services as authorized by the Florida State Board of Accountancy and the Florida Department of Professional Regulation normally performed by licensed Certified Public Accountants. More specifically to keep, examine, inspect, and audit the books and accounts of others, to devise and install financial, accounting, checking, correspondence, filing, and other office and business systems; to prepare tax returns; to compile statistics as an aid to the officers of corporations and other persons in the making of reports and statements required by tax laws; to do all such things and perform or supply all such services as are commonly done, performed, or supplied by efficiency engineers or business management experts; and to warrant the accuracy of the work done or services performed by it. In addition, this Corporation may carry on any business and have and exercise all of the powers conferred by the laws of the State of Florida, except as such may be limited by the provisions of the Florida Professional Service Corporation Act as in effect from time to time. This Corporation shall be authorized to perform every act necessary or proper for the accomplishment of the objects and purposes enumerated or for the protection and benefit of the Corporation.

**ARTICLE III. CAPITAL STOCK**

This Corporation is authorized to issue 5,000,000 shares of OneTenth of One Cent (\$.001) par value common stock.

None of the shares of the corporation may be issued to anyone other than an individual duly licensed as a Certified Public Accountant in the State of Florida.

No shareholder of this Corporation shall enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of the stock, however, the shareholder may enter into agreements with the Corporation or with each other to control or restrict the transfer of stock and such agreements may take the form of options, rights of first refusal, buy and sell agreements or any other lawful form of agreement.

#### **ARTICLE IV. ADDRESS**

The street address of the initial registered office of the Corporation shall be 325 South Olive Avenue, West Palm Beach, Florida 33401, and the name of the initial registered agent of the Corporation at that address is Richard C. Hitchins.

#### **ARTICLE V. TERM OF EXISTENCE**

This Corporation shall have perpetual existence.

#### **ARTICLE VI. DIRECTOR**

The Corporation shall have one director initially. The name and address of the initial director is:
