**ARTICLE I**

The name of the corporation is All Makes Auto Service, Inc.. The street address of the initial registered office of this corporation is 3666 South Hopkins Avenue Titusville, FL 32780. The name of the initial registered agent of this corporation at that address is James L. Richardson.

**ARTICLE II - DURATION**

The corporation shall exist perpetually, commencing at the time of filing these articles with the state of Florida.

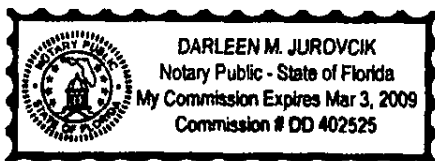

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved at the stockholders meeting and be approved by a majority of the stockholders.

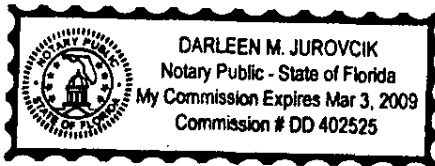
