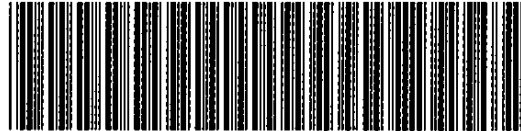

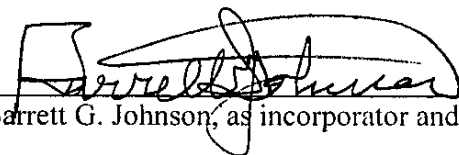

- Article I. The name of this corporation shall be McDaniell, Hunter & Prince, Inc.
- Article II. The principal place of business and mailing address of McDaniell, Hunter & Prince, Inc., shall be 1020 East Lafayette Street, Suite 204, Tallahassee, Florida 32301.
- Article III. McDaniell, Hunter & Prince, Inc. shall have as its corporate purpose the carrying on of any lawful business.
- Article IV. McDaniell, Hunter & Prince, Inc. is authorized to issue 10,000,000 shares of common stock.
