

**ARTICLE I. NAME**


### ARTICLE IX. MANAGEMENT BY SHAREHOLDERS

### ARTICLE X. BY LAWS

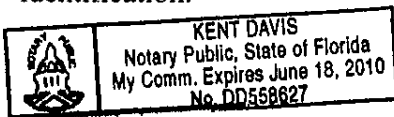
