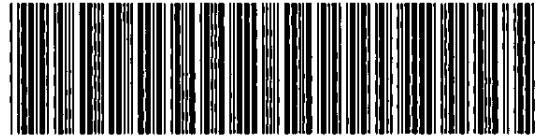

This Amendment is dated this 5th day of March, 2007.

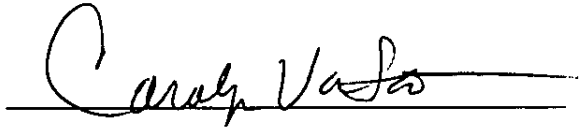
