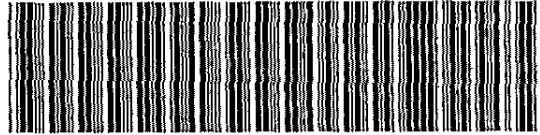

I, the undersigned, hereby set forth the following for the purpose of becoming a Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges, and immunities of a general for profit Corporation, and do hereby adopt the following Articles of Incorporation.

Article I: Name

The name of this Corporation shall be:

JG Group, Inc.

Article II: Principal Office

Article III: Purpose

The general purpose for which this Corporation is organized includes the transaction of any or all lawful business for which corporations may be incorporated under Chapter 607 of the Florida Statutes, and, including, but not limited to, any and all activities associated with the marketing, developing, promoting, selling, both wholesale and retail, procurement, transfer, trade, representation, and all other activities incident to, interior design, moving services, home

The aggregate number of shares that this Corporation shall have authority to issue shall be One Thousand (1000) shares of common class stock only with no par value. Each holder of common stock in the Corporation shall be entitled to one vote for each share of common stock held by him or her.
