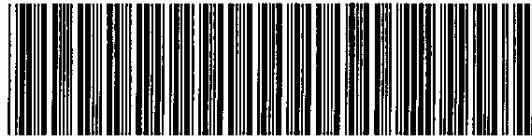

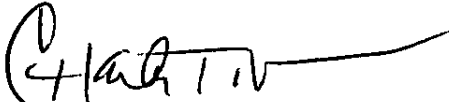

ARTICLE I

Name of Corporation

The name of this corporation is WG CONSTRUCTION SERVICES INC.

ARTICLE II

Purpose

WG CONSTRUCTION SERVICES INC. is organized primarily to develop and renovate commercial and residential real estate properties. With the approval of the board, the company may transact any and all lawful business permitted under the laws of the United States and the State of Florida.

ARTICLE III

Capital Stock

Initially, this Corporation is authorized to issue 10,000 shares of common stock at \$0.01 dollar par value.

ARTICLE IV

Corporate existence

This corporation shall exist for a perpetual period of time. It shall have offices throughout and outside the State of Florida.

ARTICLE V

Capital Stock Voting Rights

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of outstanding common shares.

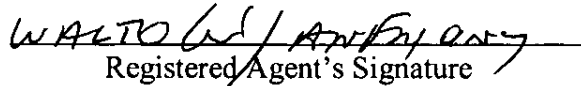

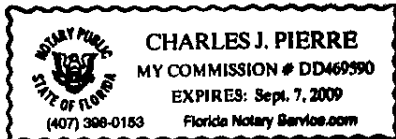
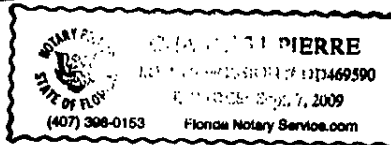
