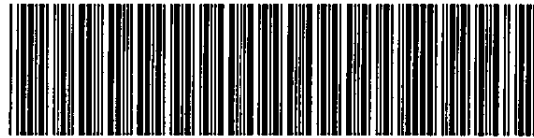

*The undersigned, acting as incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation:*

ARTICLE I – NAME

This Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

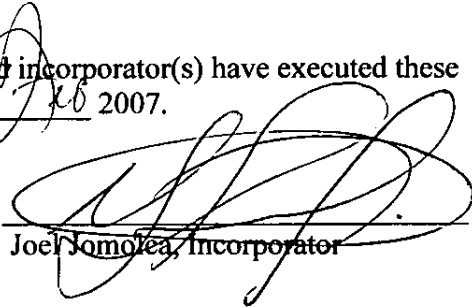
