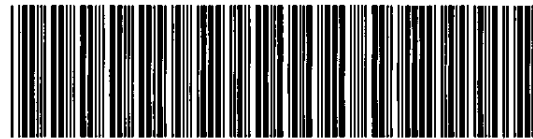

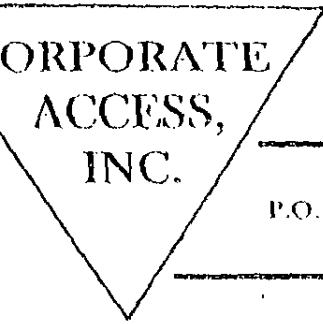

**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is **TURLEY'S LAWN & LANDSCAPING, INC.**

ARTICLE II - PRINCIPAL OFFICE

The principal place of business of this corporation shall be 2037 Kings Crossing Drive, Winter Haven, Florida 33880. The mailing address of this corporation is Post Office Box 1337, Eagle Lake, Florida 33839

ARTICLE III - PURPOSE

The corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation will have one class of stock and is authorized to have outstanding 10,000 shares (with a par value of \$1.00 per share) at any one time. The one class of stock has unlimited voting rights and, upon dissolution, is entitled to receive the net assets of the corporation.

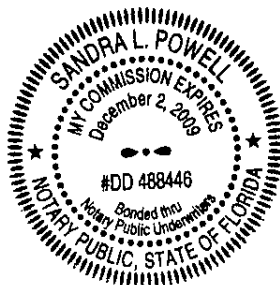
