The name of this Corporation is Discover This Company Inc.

ARTICLE II - NATURE OF BUSINESS

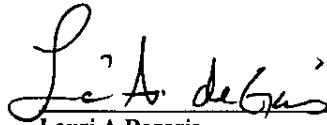

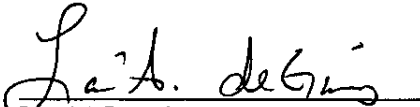
