The name of this corporation shall be ELITE CUSTOM PLUMBING, INC.

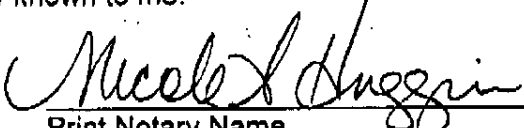

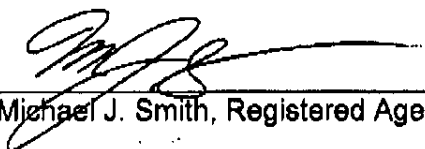
