**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
ELITE CUSTOM PLUMBING, INC.**

Pursuant to Section 607.1006 of the Florida Statutes, ELITE CUSTOM PLUMBING, INC., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The Articles of Incorporation of the Corporation were filed on February 20, 2007 and assigned document number P07000023078.
