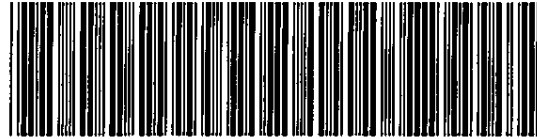



The name of this corporation is


