OF

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is SSHOOP, INC. Its principal office address and business mailing address is 20030 N.W. 3rd Ct., Miami, FL 33169.

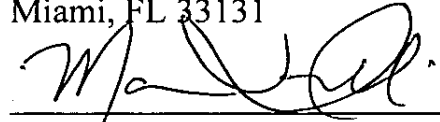

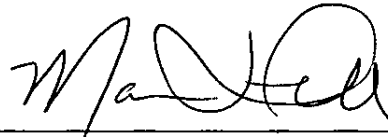
