**ARTICLES OF INCORPORATION  
OF  
PIECES OF EIGHT TITLE, INC.**

The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

**ARTICLE I  
Name**

The name of this corporation shall be: **Pieces of Eight Title, Inc.**

**ARTICLE II  
Principal Office and Mailing Address**

The address of the principal office and the mailing address of this corporation shall be 3278 Laurel Dale Drive, Tampa, Florida 33618.

**ARTICLE III  
Purposes and Duration**

The general purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Business Corporation Act of the State of Florida, and any amendments thereto, and in connection therewith, this corporation shall have and may exercise any and all powers conferred from time to time by law upon corporations formed under such Act.
