ARTICLE I: NAME

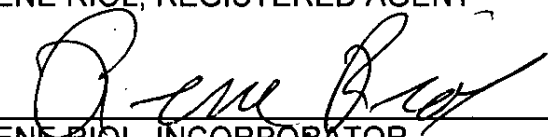
