# ARTICLES OF INCORPORATION OF VERISSIMO TECNOLOGIES, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

# ARTICLE I - NAME

The name of the corporation shall be: Verissimo Technologies, Inc.

# **ARTICLE II - DURATION**

The duration of the corporation is perpetual.

#### **ARTICLE III - PURPOSE**

The general purposes for which the corporation is organized are the following:
