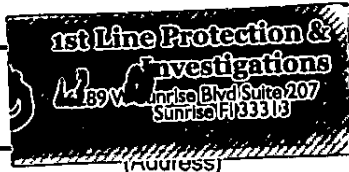

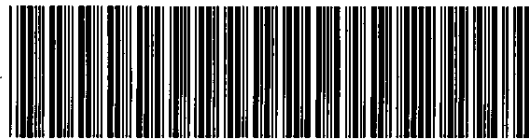

## **ARTICLE I – NAME**

The name of this corporation is: 1<sup>st</sup> Line Academy Inc.


## **ARTICLE XI – BY-LAWS**
