CORPORATE NAME

The name of this corporation is **B.M.J. TRANSPORT, INC.**

ARTICLE TWO

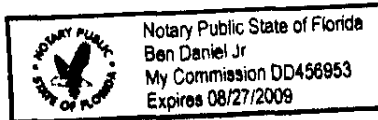
