

## ARTICLES OF INCORPORATION

#### MARKEY'S ITALIAN EXPRESS, INC.

The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a corporation under the laws of the State of Florida.

#### ARTICLE I: NAME

The name of the Corporation is

MARKEY'S ITALIAN EXPRESS, INC.

#### ARTICLE II: DURATION

The Corporation shall have perpetual existence.

#### ARTICLE III: PURPOSE

The nature of the business and the objects and purposes proposed to be transacted, promoted or carried on are to engage in any and all legal business.

#### ARTICLE IV: CAPITAL STOCK
