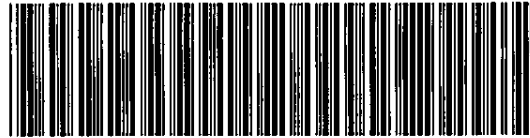

Stephen J. Walding, III, DMD	-	President


The following officer should be added:
