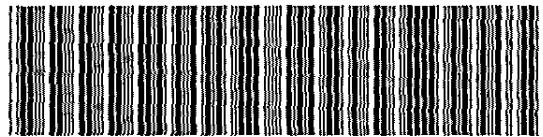

ARTICLES OF INCORPORATION

OF

51/FIFTY PRODUCTIONS, INC.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is **51/FIFTY PRODUCTIONS, INC.**

ARTICLE II. NATURE OF BUSINESS

The general nature of business to be transacted by this corporation is:

- (A) To engage in any activity or business permitted under the laws of the United States and the State of Florida.
- (B) To offer a full array of music engineering and production activities, including Creating, recording, mastering, mixing engineering and remixing music.
- (C) To create original audio post production and sound design for video, film, CD, and DVD production, music editing, studio rental, power point, sales and service, and graphic productions for individual, commercial and corporate clients.
- (D) To manufacture, purchase, or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, real and personal property, merchandise and services of every class, kind and description; except, that it is not to conduct a banking, safe deposit, trust, Insurance, surety, express, railroad, canal, telephone, telegraph or cemetery company, a cooperative association, a building and loan association, fraternal benefit society, state fair or exposition nor a mutual fire insurance association.
- (E) To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, copyrights, patents, licenses and trademarks, in the State of Florida and in all other states and countries. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property, or other instruments to secure the payment of corporate indebtedness as required.

To guarantee, transfer, hold, purchase, endorse, sell, pledge, mortgage or otherwise acquire or\dispose of the shares of the capital stock of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida, or any other state or government, and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.

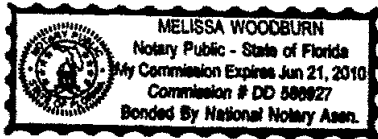
