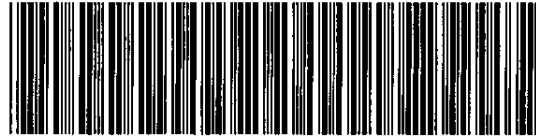

In compliance with the requirements of F.S. Chapter 607 and 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: Robert A. Zurawiecki, M.D., P.A.

ARTICLE II

The existence of the Corporation shall begin on: February 19, 2007.

ARTICLE III

The street address of the principal office of the Corporation is: 7454 SW 115th Court, Miami, Florida 33173.

ARTICLE IV

The specific purpose for which the Corporation is organized is the practice of medicine by a physician. The Corporation is a Professional Association for Robert A. Zurawiecki, M.D., who is a medical doctor licensed to practice medicine in the State of Florida.

The maximum number of shares this Corporation is authorized to issue is 100, par value \$1.00 per share, all of which shall be Common Shares.




