ARTICLES OF INCORPORATION
OF
R AND S PROFESSIONAL CORPORATION

ARTICLE I - NAME

The name of the corporation is R And S Professional Corporation.

ARTICLE II - DURATION

The corporation shall exist perpetually.

ARTICLE III - PURPOSE
