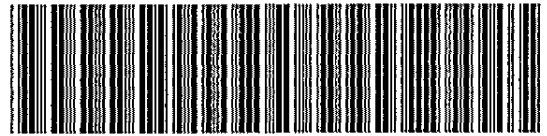

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is ALLGOOD TOTAL LAWN MAINTENANCE, INC. and its principal place of business shall be located at 487 Shady Creek Lane, Clermont, Florida 34711.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.
