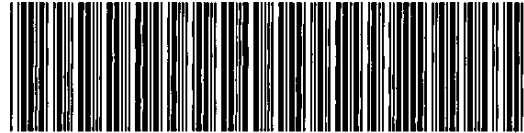

**ARTICLES OF INCORPORATION
OF
BRETT REIS ENTERPRISES, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: Brett Reis Enterprises, Inc.

ARTICLE II

The street address of the principal office of the Corporation is: 1352 Warrior Way, Tallahassee, FL 32304.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 10,000, all of which shall be Common Shares. 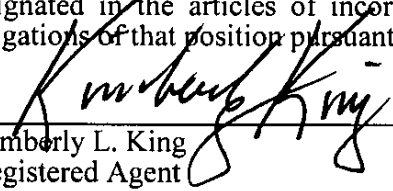
