ARTICLES OF INCORPORATION

These Articles of Incorporation are adopted for the purpose of forming a corporation under the laws of the State of Florida, to be filed with the Florida Department of State, as follows:

ARTICLE ONE: NAME

The name of the corporation is QAA Fidu, Inc., and the address of its principal office is 3908 26th St W, Bradenton, FL 34205, until and unless such address is subsequently changed by the corporation.

ARTICLE TWO: COMMENCEMENT AND DURATION

The corporation shall commence its corporate existence as of 27 February 2007 and it shall exist perpetually thereafter until dissolved according to law.

ARTICLE THREE: PURPOSE

The corporation is organized for the primary purpose of providing fiduciary services as a trustee of land trusts established pursuant to \$689.071 of the Florida Statutes, including any and all ancillary or related activities, transactions, and business related thereto.

Notwithstanding the foregoing, the corporation shall be permitted to transact any and all business permitted corporations under Florida law.

ARTICLE FOUR: CAPITALIZATION

The corporation shall have the authority to issue 100 shares of common stock with a par value of one penny per share.

ARTICLE FIVE: DIRECTORS AND OFFICERS

The corporation shall be served by a board of one director. Until replaced by action of the shareholders in accordance with the Bylaws, the director of the corporation shall be Marc H. Feldman, whose address is 3908 26th St W, Bradenton, FL 34205.

The corporation shall be served by the offices of a President, a Secretary, and a Treasurer; however, one person may hold more than one position as an officer of the corporation. Until replaced by action of the Board of Directors in accordance with the Bylaws, the President, Secretary, and Treasurer of the corporation shall be Marc H. Feldman, whose address is 3908 26th St W. Bradenton, FL 34205.

ARTICLE SIX: REGISTERED OFFICE AND AGENT

The Registered Office of the corporation is to be in Manatee County, Florida, at 3908 26th Street West, Bradenton, Manatee County, Florida 34205, and the Registered Agent at that address is Marc H. Feldman.

ARTICLE SEVEN: INCORPORATOR
