ARTICLES OF INCORPORATION OF Law Offices of Walter H. Djokic PROFESSIONAL ASSOCIATION

The undersigned Incorporator, a natural person competent to contract, each of whom is licensed to practice law in the State of Florida, hereby forms a corporation under the Florida Professional Service Corporation Act.

ARTICLE I- NAME

The name of this Corporation shall be:

Law Offices of Walter H. Djokic Professional Association

ARTICLE II-TERM AND COMMENCEMENT OF EXISTENCE

The corporation is to exist perpetually. This corporation shall commence to exist on the date of filing.
