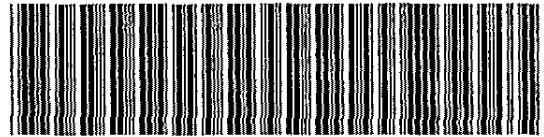

**ARTICLES OF INCORPORATION  
OF  
Law Offices of Walter H. Djokic  
PROFESSIONAL ASSOCIATION**

The undersigned Incorporator, a natural person competent to contract, each of whom is licensed to practice law in the State of Florida, hereby forms a corporation under the Florida Professional Service Corporation Act.

**ARTICLE I- NAME**

The name of this Corporation shall be:

**Law Offices of Walter H. Djokic  
Professional Association**

**ARTICLE II-TERM AND COMMENCEMENT OF EXISTENCE**

The corporation is to exist perpetually. This corporation shall commence to exist on the date of filing.

**ARTICLE III-PURPOSE OF CORPORATION**

This corporation is organized for the following purposes:

- A. To engage in the practice of law as a professional law corporation, and to carry on services incident thereto. The practice of law is the sole and exclusive professional service to be rendered by this corporation.
- B. To own property, enter into contracts, invest and to carry on any business necessary or incidental to the accomplishment or furtherance of the purpose of objects of this corporation.
- C. To do everything necessary, proper or convenient for the accomplishment of any of the purposes herein set forth and to do every other act incidental thereto which is not forbidden by the law of the State of Florida.
- D. The professional services of this corporation shall be carried out only through officers, employees and agents, each of whom has been admitted to the bar of and is duly authorized to practice law in the State of Florida.

#### **ARTICLE IV-CAPITAL STOCK**

The aggregate number of shares, which the corporation shall have authority to issue, is One Hundred (100) shares of common stock having a per value of One (\$1.00) Dollar per share.

#### **ARTICLE V-NAME OF REGISTERED AGENT AND ADDRESS OF REGISTERED OFFICE**

Initially this corporation shall initially have one (1) director. The number of directors may be either increased or diminished from time to time by by-laws adopted by the stockholders.



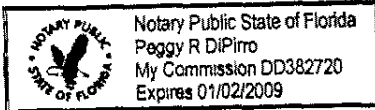
