The undersigned, in order to form a corporation for the purpose hereinafter stated. under and pursuant to the General Corporation Act of the State of Plorida, do hereby certify as follows:

ARTICLE I - NAME

The name of this corporation is: ALPAC INVESTMENTS, INC

ARTICLE II - PURPOSE

The general nature of the business to be transacted by this corporation shall be:
