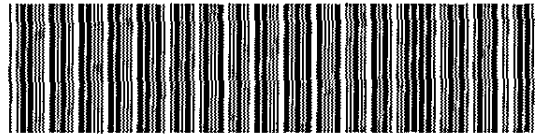

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Star Studios of Miami, Inc.

ARTICLE II - PRINCIPAL OFFICE
