ARTICLES OF INCORPORATION

OF

JENTIFF, INC., A FLORIDA CORPORATION

Pursuant to the provisions of Chapter 607, Florida Statutes, as amended, the following are hereby adopted and filed as the Articles of Incorporation of this Florida corporation for profit:

ARTICLE I - NAME

The name of this Corporation shall be: JENTIFF, Inc.
