# ARTICLES OF INCORPORATION

Pursuant to the provisions of Chapter 607, Florida Statutes, as amended, the following are hereby adopted and filed as the Articles of Incorporation of this Florida corporation for profit:

# ARTICLE I - NAME

The name of this Corporation shall be: Hanania Automotive Corp. Four

# ARTICLE II - INITIAL PRINCIPAL OFFICE

The initial principal place of business of the Corporation is:

Each outstanding share, regardless of class, shall be entitled to one (1) vote on each matter submitted to a vote at a meeting of the Shareholders, unless otherwise designated as "NONVOTING" by a resolution recorded in the Corporate Minute Book and a similar legend on the subject certificate(s). The shares of stock may be issued for such consideration, having a value not less than the par value of the shares issued therefor, as such value is determined from time to time by the Board of Directors. Said consideration is to be paid in cash or other property, tangible or intangible, or in labor or services actually performed for the Corporation.

# ARTICLE VI - INITIAL REGISTERED AGENT AND OFFICE

# ARTICLE VII - INITIAL BOARD OF DIRECTORS
