

CERTIFICATE AND ARTICLES OF INCORPORATION

The undersigned person, having the age of eighteen (18) years or more, has associated himself for the purpose of forming a corporation under the laws of the State of Florida and does hereby adopt the following Certificate and articles of Incorporation.

- 1. Name. The name of this corporation is Travis Prince, P.A.
- 2. Purpose and Powers. This corporation is organized for the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time, and specifically but not limited thereof, the purpose of: Commercial Real Estate Sales
- 3. Duration. The duration of the corporation shall be for in perpetuity.
- 4. Statutory/Registered Agent. The corporation appoints Travis Prince, who is a bona fide resident of Florida. This appointment may be revoked at any time in accordance with the rules of the State of Florida.

- 6. Board of Directors. The number of directors of the corporation shall be fixed and may be altered from time to time as may be provided in the bylaws. In case of any increase in the number of directors, the additional directors shall be elected by the shareholders at an annual or special meeting, as shall be provided in the bylaws.
 - The initial Board of Directors shall consist of one person, who shall serve until his successors are qualified according to the bylaws, and whose name and address is: Travis Prince, 10265 Gandy Blvd #1808, St Petersburg, FL 33702
- 7. Amendment of Bylaws. Both the shareholders and the board of directors shall have the power to amend the bylaws as provided in the bylaws.

- Commencing Business. The minimum amount of capital with which the corporation shall commence business is one hundred (\$100.00) dollars.
- 9. Capital Stock.
