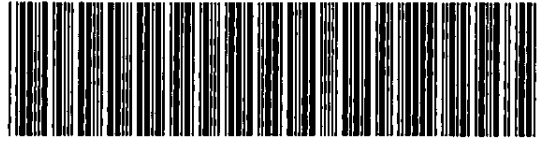

The undersigned hereby organizes a corporation for profit under the provisions of the Florida Professional Service Corporation and Limited Liability Act ("Act"), and pursuant to the following Articles of Incorporation.

ARTICLE 1

Name

The name of this corporation is: **LISA HITT, P.A.**

ARTICLE 2

Mailing Address

The mailing and street address for the principal office of this corporation is: **10131 DOWNEY LANE, TAMPA, FL. 33626.**

ARTICLE 3

CORPORATION PURPOSES, POWERS & RIGHTS

The nature of the business to be conducted or promoted and the purposes of the corporation are to engage in the practice of real estate and any lawful act or activity for which a professional service corporation engaged in such profession may be organized under the Act, and in which such a corporation is permitted to engage under applicable law.
