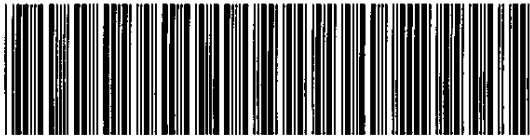

SIXTH: The net assets of the corporation remaining after winding up have been distributed to the shareholders, if shares were issued. No shares were issued and there were no assets to be distributed.


