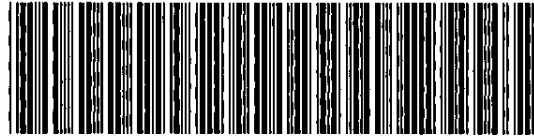

The initial director of the Corporation is Gideon Leaks., 110 N. Albany Ave., Tampa, Florida,

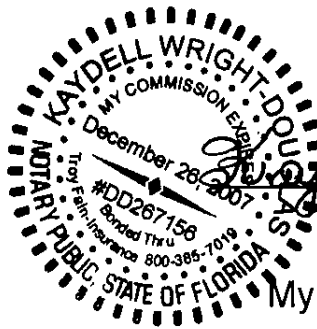
