ARTICLES OF INCORPORATION OF <u>FORESIGHT INDUSTRIES, INC.</u>

The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I Name

The name of this corporation shall be: Foresight Industries, Inc.

ARTICLE II Principal Office and Mailing Address

The address of the principal office shall be 695 Central Avenue, St. Petersburg, Forda 19701 and the mailing address of this corporation shall be P.O. Box 27412, Tampa, Florida 33623.

ARTICLE III Purposes and Duration

The general purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Business Corporation Act of the State of Florida, and any amendments thereto, and in connection therewith, this corporation shall have and may exercise any and all powers conferred from time to time by law upon corporations formed under such Act.

ARTICLE IV Capital Stock
