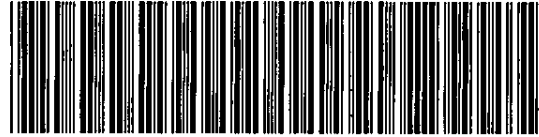

**ARTICLES OF INCORPORATION
OF
AXOS TITLE, INC.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

AXOS TITLE, INC.

ARTICLE II

NATURE OF BUSINESS

This corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE III

CAPITAL STOCK

The maximum number of shares that this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares at no par value.

ARTICLE IV

TERM OF EXISTENCE

The existence of this corporation shall commence on March 15, 2007, and this corporation shall have perpetual existence.

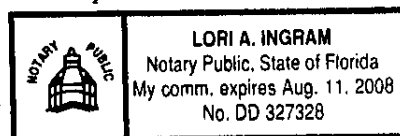
