ARTICLES OF INCORPORATION
OF
ZERBINI FAMILY CIRCUS, INC

#### ARTICLE I

Name. The name of this corporation is ZERBINI FAMILY CIRCUS, INC.

# ARTICLE II

Duration. The corporation shall be perpetual.

### ARTICLE III

<u>Purpose</u>. This corporation is organized for the purpose of transacting any or all lawful business.
