

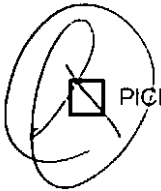

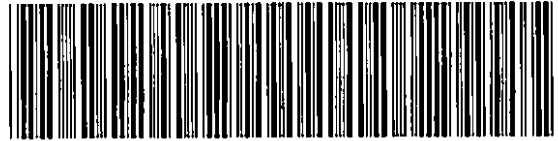

**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF USWC HOLDING COMPANY**

Pursuant to Section 607.1006, Florida Statutes, the above-named Florida profit corporation (Document Number P07000028386) adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Article II of the Articles of Incorporation is amended to read as follows:

**ARTICLE II
PRINCIPAL OFFICE**

The principal office of the Corporation shall be located at 14755 North Outer Forty Drive Chesterfield, MO 63017. The Corporation may establish and maintain the principal office of the Corporation at such other place within the State of Florida or elsewhere as may be determined by the Board of Directors.

SECOND: The amendment does not provide for an exchange, reclassification or cancellation of issued shares, and therefore there are no related provisions for implementing the changes.

THIRD: The effective date of the amendment's adoption is December 31, 2020.

FOURTH: The amendment was adopted by the shareholder. The number of votes cast for the amendment by the shareholder was sufficient for its approval.
