ARTICLES OF INCORPORATION

OF

AFTERTHOUGHT & BEFORE, INC.

I, the undersigned subscriber to these Articles of Incorporation, being analyzed person competent to contract, do hereby make, subscribe, acknowledge, and file these Articles for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be AFTERTHOUGHT & BEFORE, INC. The mailing address and the street address of the initial principal office of this corporation is 1077 Hwy. 98 East, Suite #100, Destin, FL 32541.

ARTICLE II

The corporation shall have perpetual existence, beginning on the date of filing of these Articles of Incorporation in the Office of the Secretary of State of the State of Florida.

ARTICLE III

This corporation is organized for the purpose of transacting any and all lawful business, both withir and without the State of Florida.

ARTICLE IV

This corporation is authorized to issue ten thousand (10,000) shares of common stock, each share having a par value of One Dollar (\$1.00). No shares without nominal or par value shall be issued.

ARTICLE V

Every shareholder, upon the sale for cash of any new stock of this corporation, shall

have the right to purchase a pro rata share thereof, as nearly as may be done without issuance of fractional shares, at the price at which it is offered to others.

ARTICLE VI

The street address of the corporation's initial registered office is 125 W. Romana Street, Suite 800, Pensacola, FL 32502. The name of the corporation's initial registered agent at that office is Gary W. Huston.

ARTICLE VIL

This corporation shall have one (1) director initially. The number of directors may be either increased or decreased from time to time as provided in the Bylaws of the corporation, but the rumber of directors of the corporation shall not be less than one nor more than nine.

ARTICLE VIII

ARTICLE IX

At each election for directors, every shareholder entitled to vote at such election shall have the right to accumulate his vote by giving one candidate as many votes as the number of directors to be elected at that time, multiplied by the number of his shares, or by distributing such votes on the same principle among any number of such candidates.

ARTICLE X

This corporation shall have all of the corporate powers set forth in the Florida General Corporation Act, Chapter 607, Florida Statutes, as such chapter presently exists or
