ARTICLES OF INCORPORATION OF BERIRO, P.A.

The undersigned, desiring to organize a Professional Service Corporation for the purpose hereinafter stated, pursuant to the laws of the State of Florida, hereby certifies as follows:

ARTICLE I Name

The name of the corporation is BERIRO, P.A., and its principal business address is 214 Brazilian Avenue, Suite 200, Palm Beach, Florida 33480.

ARTICLE II Duration

This corporation shall be perpetual existence.

ARTICLE III Purpose

The general nature of the business to be transacted by the corporation shall be to engage in the practice of law. The professional services involved in the corporation's practice of law may be rendered only through its officers, agents and employees who are duly authorized and licensed to practice in the State of Florida.

The corporation shall not engage in any other business other than the practice of law. However, the corporation may invest its funds in real estate, mortgages, stocks, bonds and other types of investments, and may own real and personal property necessary for the rendering of the professional services authorized hereby.

ARTICLE IV Capital Stock

This corporation is authorized to issue 1,000 shares of ONE DOLLAR (\$1.00) par value common stock.

ARTICLE V Initial Registered Office and Agent

The street address of the initial registered office of this corporation shall be 214 Brazilian Avenue, Suite 200, Palm Beach, Florida 33480 and the name of the initial registered agent of this

ARTICLE VI Initial Board of Directors and Officers

This corporation shall have one (1) director initially. The name and address of the initial directors of the corporation, who shall hold office until their successors are elected and qualified or until their earlier resignation or removal from office are:

This corporation shall, to the fullest extent permitted by the provisions of Florida Statutes Section 607.0850, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said provision from and against any and all of the expenses, liabilities or other matters referred to in or covered by said provisions, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any bylaw, agreement, vote of shareholders or disinterested directors or otherwise, both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director or

officer, and shall inure to the benefit of the heirs, executors and administrators of such person.

ARTICLE X Amendment

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholder(s) is subject to this reservation.

ARTICLE XI Bylaws

The bylaws may be adopted, altered, amended, or repealed by either the shareholders or the Board of Directors, but the Board of Directors may not amend or repeal any bylaw adopted by shareholders if the shareholders specifically provide such bylaw is not subject to amendment or repeal by the directors.

ARTICLE XII Beginning of Corporate Existence

Corporate existence shall begin upon the filing of these Articles of Incorporation.

ARTCILE XIII Sub-Chapter S Corporation

This corporation may elect to be treated as a Sub-Chapter S Corporation as defined by the Internal Revenue Code.
