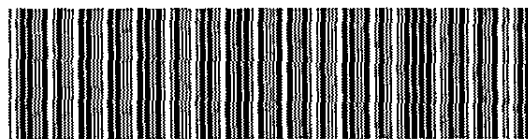




ARTICLE IX. AMENDMENT
