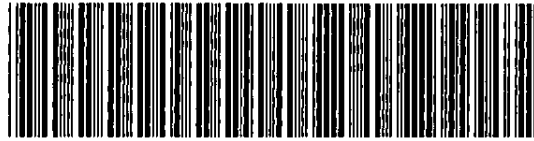

**ARTICLE X**




