ARTICLE I

The name of this corporation shall be The Gators Two, Incorporated. The Gators Two, Incorporated. ("The Company") shall be established as an S Corporation for purposes as they regard The Internal Revenue Service or for other tax filings.

ARTICLE II

The purpose for which this company is organized is for all purposes allowed a Florida corporation.

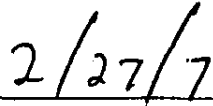
ARTICLE X

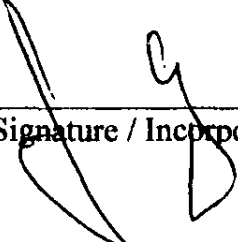

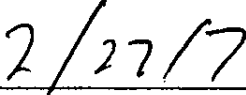
