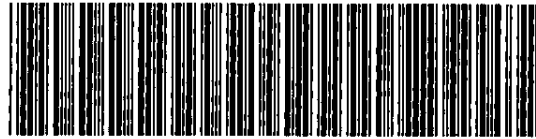

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I – NAME**

The name of this corporation is Chadrick E. Wilkinson, P.A.

**ARTICLE II- PURPOSE AND POWERS**

The corporation is formed as a professional association for real estate sales associate; to provide realtor services.

**ARTICLE III- INITIAL CAPITAL**

The amount of capital with which this corporation will commence business with shall not be less than One Hundred Dollars (\$100.00).

**ARTICLE IV- CAPITAL STOCK**

The amount of capital stock authorized shall be One Hundred (100) shares of common stock, with a par value of One Dollar (\$1.00) per share. Stock shall be issued under Section 1244 of the Internal Revenue Code.


