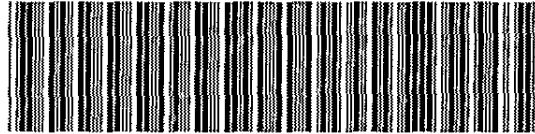

The name of this corporation is SALLY FLOWER'S BEAUTIFUL BLOOMS, INC.

Article Two: Purposes

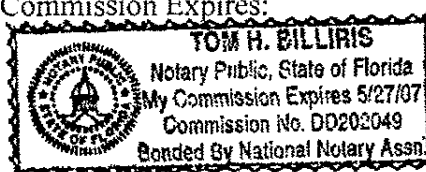
